3rd MEETING OF THE INSARAG Guidelines Review Group (GRG) 2018-2020

CO-CHAIRS' SUMMARY Geneva, Switzerland, 4 to 8 Feb 2019



BACKGROUND

The INSARAG Steering Group (ISG), at its meeting in 2018 and 2019, endorsed the following GRG decisions:

ISG 2018

- 1. Co-Chairs from different regions to lead the GRG with technical experts and meeting the ToRs shared with the network.
- 2. Invite previous GRG members and with support from their respective organisations to ensure continuity of institutional knowledge and experience is maintained.
- 3. Chairs of existing Working Groups will be co-opted members and engaging with relevant partners and agencies when needed.
- 4. The GRG will take into account the suggestions from 2017 regional discussions and widely consult with the Regional and Team leader groups physically in the respective meetings and on-line, and report back to the ISG.
- 5. A Technical Reference Resource Library will be considered by the GRG.
- 6. The tenure of the GRG will be from 2018 to 2020 -with the launch of the Revised version 2020 to coincide with the INSARAG Global Meeting in 2020.

ISG 2019

- 1. The guidelines review had transited into Phase 2 and the GRG would be reorganised into thematic groups to commence looking into the individual volumes and integrate the proposed amendments and inputs gathered from Phase 1.
- 2. The GRG had finalised on features of the Technical Reference Resource Library and would be discussed with the respective regional and Team Leader groups for feedback.
- 3. The GRG had engaged Mr David Woods as its technical writer and Version 1.0 of the review guidelines would be ready by July 2019 for feedback from the respective regional, Team leader groups.
- 4. The GRG would continue to consolidate suggestions and inputs from regional and Team leader groups physically in the respective meetings and on-line.
- 5. Version 2.0 of the reviewed guidelines would be finalised with co-chairs and WG leaders in Feb 2020 and would be reported back to ISG for endorsement during the ISG 2020 meeting in Mar/Apr 2020.

Since its formation in 2017, GRG 2020 has actively engaged the INSARAG community through the following platforms as outlined in <u>Table 1</u>.

OPENING ADDRESS

Mr Jesper Holmer Lund, Chief OCHA Emergency Response Services Branch, opened the 3rd GRG Meeting. He shared on the major achievements which the INSARAG had achieved over 2018 like the INAP and USAR Coordination (UC) which enhanced the disaster response capacity of local and international USAR teams. He also stated that UN OCHA and INSARAG would continue to bolster partnerships, integrate humanitarian response with USAR and enhance it's beyond the rubble capability

Mr Anwar (Singapore) updated the meeting on the progress achieved by the GRG since 2018 and highlighted that the <u>GRG had transited into Phase 2 of the guidelines review since the Team Leaders Meeting last year in</u> <u>Bucharest</u>, as well as sharing on feedback received from the engagement session from the Asia Pacific Regional Meeting. Mr David Sochor (Switzerland) and Mr Sebastian Mocarquer (Chile) shared on the feedback received from the engagement sessions during the AEME and Americas Region Meeting. 2020 INSARAG GUIDELINES REVIEW

Reorganised Thematic Groups and Document Keepers

Noting the transition to Phase 2, the meeting agreed on: (i) the reorganised Thematic Groups and (ii) the appointment of document keepers for each of the Volume/Manual (including the technical reference library) as outlined in <u>Table 3</u> and <u>Diagram 1</u> below.

The meeting also noted that the re-organised Thematic Groups would commence looking into the individual volumes and harmonise Phase 1 inputs. Any revision to the documents (with the changes tracked) would need to be submitted to them for uploading onto the UNDAC Mission Software (through Luigi Bruno, OCHA) - *All revisions (including changes to checklists or annexes) would be included into the relevant volumes and manuals accordingly.*

Engagement of Review Writer

The meeting welcomed the introduction of Mr David Woods (Ireland) as the official guidelines technical writer. Mr David Woods was invited by Mr David Sochor (Switzerland) to ensure consistency in the version of the Guidelines.

Amendments to Guidelines (Endorsed by ISG 2019)

The meeting was organised into discussion groups led by the respective document keepers to collate on the proposed amendments to the guidelines. <u>The proposed amendments below were subsequently presented by Mr David</u> <u>Sochor (Switzerland) and endorsed during the ISG 2019 meeting as outlined in Table 4 below.</u>

Technical Reference Resource Library (Endorsed by ISG 2019)

The meeting came to a common consensus on the Technical Reference Resource Library features as outlined in <u>Table 5</u> below. The features were subsequently presented by Mr Anwar (Singapore) and endorsed during the ISG 2019. The meeting also agreed that the endorsed features would be shared during the respective 2019 regional and Team Leader Meeting for feedback.

On the deliberation if the library should have a <u>discussion platform</u>, the meeting agreed that they would leverage on the INSARAG Facebook page as a trial discussion platform to measure the level of enthusiasm for the discussion platform.

Open Door GRG Review Discussion Session

The meeting hosted an open door session to obtain feedback on the guidelines amendments and technical reference library. The collated feedback is as outlined in <u>Table 6</u> below.

S/N	Feedback/Response
1	General consensus that the changes made by the GRG were sufficient.
2	General consensus that a knowledge repository platform was required to enable information sharing with the USAR community.
3	The audience suggested there has to be a mechanism which enabled the reader to seek inputs and advice on the shared material. The GRG members informed that the INSARAG Facebook page would be trialed as an interim discussion platform as a measure of its demand. Audience members were also advised that they could to discuss with the Operational Focal Points.
4	The audience suggested that the endorsement and material sharing workflow (i.e. who would upload the material unto INSARAG.org? could there be more than one endorser?) could be enhanced. The GRG members noted the feedback and informed that more details on the platform would be shared for inputs (during regional and Team Leader's meetings) upon endorsement by ISG 2019.

GRG Discussion on ISG 2019 6 Endorsed Items

The meeting discussed on the potential impact of items endorsed during ISG 2019 on the Guidelines: (i) NAP/INAP, USAR Coordination, (ii) Information Management Implementation, (iii) International Light Team IEC, (iv) Strengthening the INSARAG and IEC/R Quality Assurance system (v) Global INSARAG Strategy 2020 to 2025 and (vi) the presentation by co-chairs Mr Anwar Abdullah (Singapore) and Mr David Sochor (Switzerland) INSARAG Guidelines Review Version 2020. For more information on the ISG's decision, refer to Annex B.

On the endorsement of **LTWG's proposal** for USAR teams to be able to demonstrate the capacity to downsize (i.e. heavy to medium, medium to light). The meeting agreed that LTWG would need to clarify on how should the teams should demonstrate the capacity (i.e. teams would need to demonstrate the ability to downsize to light or medium teams during their IER).

The meeting also agreed that more conversation was needed for advancing <u>flexible assistance</u> - highlighted in the concept note for the Global Meeting in 2020. GRG members agreed that the guidelines should mention the deployment of USAR teams for non-USAR operations as part of bilateral co-operations in Vol I and Vol II, Manual A

On the endorsement of <u>Global INSARAG Strategy 2020 to 2025</u> to strengthen partnership, GRG deliberated that some basic information on how INSARAG would interact with its partners (UNESCO, Interpol etc.) should added be into the Guidelines.

The meeting also noted Japan's suggestion on the need to enhance the information on a country's <u>receiving</u> <u>mechanism</u>. Mr Anwar (Singapore) informed that the JPN team would share their inputs through Mr David (Switzerland) for the GRG consideration.

On the endorsement of <u>Strengthening the INSARAG and IEC/R Quality Assurance system</u>, the meeting noted that the IEC/R checklist would be separated into two separate checklists with distinction between the different classifications as outlined below. The meeting also noted that TWG would share more information on the progress of the checklist for implementation into "Guidance Notes" section

The meeting agreed to maintain a document which contains: (i) a summary on the changes made for each volumes for the transitional Guidelines Review Group and (ii) a feedback segment. The deck would also serve as a useful reference materials and progress report to share with the Regional Meetings and Team Leader.
