INSARAG 2020 regional work plan Americas & Caribbean Regional Group (version April 2020)





Priorities:

In its annual meeting of 2019¹, The Regional Group defined the following priorities for 2020:

- Contribute to the definition of INSARAG global strategies and priorities
- Strengthen the IRNAP process
- Strengthen USAR coordination capacities in the region
- Strengthen partnerships with "sister" response networks and other partners to increase the efficiency of emergency preparedness and response

These priorities were presented by the Regional Chair to the INSARAG Steering Group in February 2020 and received full endorsement. Since then, all regions across the world have been affected by the Covid-19 pandemic, which has a dramatic impact in all aspects of life, at social and economic level, and has further aggravated the situation of vulnerable populations and those in need of humanitarian assistance.

The INSARAG network is adapting to the new reality. In the regional context of the Americas and the Caribbean, the Regional chairmanship group under the leadership of Colombia as Regional Chair is coordinating the required adaptations. On the one hand, all teams are encouraged inasmuch as possible to prepare for a potential response in a Covid-19 environment²; and on the other hand, alternative ways are being sought to implement activities of the regional work plan.

Below is the adapted road map for each of the objectives for the year 2020 in the region.

I. Contribute to the definition of INSARAG global strategies and priorities

Context and problem statement: The INSARAG network is in the process of defining a new global strategy for the period of 2020-25, which is expected to be adopted jointly with the "Warsaw declaration" at the 2020 INSARAG Global Meeting. The consultations continue on the strategic direction that the INSARAG community intends to give to the priority themes (coordination, flexible response, localisation, partnerships), jointly with the consultations on the draft version of the Warsaw declaration, and the region of the Americas has much to contribute in each of them.

II. Strengthen the IRNAP process in the region and globally

Context and problem statement: The Americas region pioneered the development of the guidance currently found in the INSARAG Guidelines on national USAR team accreditation processes. In 2017, the INSARAG Steering Group adopted the INSARAG External Support and Recognition Process (IERSP or PAREI in Spanish) of USAR national accreditation processes. Since then, this process has triggered a high level of interest in all regions leading to the need for additional coordination and update of the guidance that is being provided, which is why the INSARAG Steering Group in 2020 endorsed the recommendation from the region to establish a specific Working Group on this topic. In the context of the update of the INSARAG 2020 Guidelines, the guidance was updated into a Technical Guidance note and the name updated to be called INSARAG Recognized National Accreditation Process (IRNAP).

Likewise, and in parallel, it is necessary to strengthen the capabilities of IRNAP implementation at the regional level of the Americas and expand membership in the regional roster of experts that are part of the Technical Support Group (TSG) and the technical recognition group (TRG), according to the newly proposed terminology.

III. Strengthen USAR coordination capacities in the region

Context and problem statement: Since the first publication of the UCC (USAR Coordination Cell) manual, four UCC regional courses have been carried out, two of them in English with the participation mainly of classified team personnel, and two of them in Spanish with the participation of staff from national emergency management agencies and national USAR teams. Although these courses contributed to the training of many individuals across the region, the countries of the region continue to express the need for actual or additional capacity to set up USAR coordination cells with their own capabilities, showing the need for additional training to be done at the national level.

The existing UCC course was designed primarily for an international USAR team audience. As part of strengthening national coordination capacities, the INSARAG Americas group identified the need to develop a national USAR coordination course module and train the group of instructors for this course. This will be done in consultation with the INSARAG Training working group and it will allow the region to count on a capacity for regional collaboration (instructors trained to deliver a course based on the INSARAG methodology) for the strengthening of national and local capacities in the establishment and management of a USAR coordination cell.

IV. Strengthen partnerships with "sister" response networks and other partners to increase the efficiency of emergency preparedness and response

Context and problem statement: The INSARAG regional group in the Americas has close ties with the EMT Regional Group and will continue to strengthen this collaboration since several of the response scenarios, coordination mechanisms and capacity building efforts are similar, despite the specialties being clearly different. 2019 also resulted in the confirmation of a new partnership with the Organization of American Firefighters (OBA) which joined the Regional Group in the promotion and implementation of the INSARAG methodology with its partners and members and offered its support to activities of the Regional group.

One key activity in which all partners collaborate to enhance coordination and response protocols is the regional SIMEX. Although there is no regional SIMEX planned for 2020, it is expected to start with the preparation of SIMEX 2021 in Peru, which shall take place in the first part of the year 2021.
