
National Search and Rescue Agency of Republic Indonesia (Basarnas) hosted the 2022 AP ERE to increase the preparedness of Indonesia USAR Team and national stakeholders in facing the worst-case scenario of a major disaster, namely the mitigation of unpredicted megathrust in Indonesia, to prepare in supporting Indonesia's Presidency of the G20, as well as to commemorate the golden year of Basarnas in 2022.

This exercise using the command post exercise method that involves 5 USAR elements from the national and international levels in reference to INSARAG Guideline.



Scenario of Exercise

Basarnas developed an exercise scenario situated in the north of Bali Province with a large-scale earthquake of 7.4 on the richter scale that resulted in thousands of casualties. Due to the consequences of the large number of affected areas and casualties that exceed the national response capacity, the scenario simulated the request for international assistance to support Indonesia's in country USAR teams to implement on site disaster emergency response, including the implementation of the Covid-19 protocol and handling the ruins of historical and religious sites in Bali Province.















This large-scale disaster exceeds the capacity of disaster emergency response at local and national levels, thus requiring international assistance such as the USAR Team, Emergency Medical Team (EMT), United Nations Disaster Assessment and Coordination (UNDAC), and the ASEAN Emergency Response and Assessment Team (ASEAN ERAT). Basarnas also involved the Indonesia's NAP of USAR Teams to experience working alongside international USAR teams in close coordination.

Conclusion

- All humanitarian actors took the opportunity of this exercise to enhance and improve close coordination nationally and internationally.
- Indonesia through Basarnas and with the support of relevant stakeholders took the AP ERE 2022 activities as part of Basarnas' preparedness to face the worst scenario of a major disaster, namely the projection of unpredicted megathrust in Indonesia.



First Responders Program 2.0 developed by TWG - Update



- The FRT 2.0 is now in its testing phase: To ensure that the new training fits to the various demands worldwide, there will be four test trainings in the regions:
- In SEP 2022 the 1st test was done in Germany (THW USAR Training Centre) with master trainers from Georgia. The focus was set especially on didactic and methodology and led to numerous changes in the initial draft of the new training course. The presentations are now in translation into Sorani language
- The 2nd test will happen in Iraq in NOV 2022. It will prove if the simplified English will help for better translation and also test the options for localization
- As an interim, there will be a workshop with Sri Lanka in December to integrate the experiences made with localized FRT for professional FR
- Test No. 3 and 4 will happen in early 2023 in Ecuador and Indonesia. This will be the first end user tests i.e., with real (non-professional) First Responders to find out if the content will be adopted by the participants
- In March 2023 the revision of the material towards the final version will be happen – ready to be endorsed in the Steering Group Meeting

Reasons for Flexible Response Working Group

- Changing Global disaster and humanitarian landscape
 - Primarily Weather driven
 - INSARAG too must change and adapt






Definition 'Beyond the Rubble' or 'Flexible Response'?

"Beyond the Rubble", INSARAG Guidelines VII, Man B:


- activities offered/conducted by USAR Teams deployed
- after an earthquake or other sudden onset disaster
- to overcome the transitional phase between the USAR and the early recovery/relief phase.
- These tasks are driven by the needs of the community as identified by the LEMA.



"Flexible Response"

- Activities offered/conducted by USAR Teams (at Home)
- deployed after an earthquake or other sudden onset disaster
 - Tailored response to meet specific activities as requested by the affected country
 - The Flexible response team deploys to meet specific activities

The AP region supports Flexible Response and the following recommendations:

- a. INSARAG Teams with additional capacities e.g. water search and rescue
 - a. indicate their capabilities and capacities to INSARAG Secretariat.
 - b. including equipment and operational duration,
 - c. Secretariat will have a catalogue of modular capabilities, matched to needs when they arise.
 - d. Deployments would use the INSARAG system and methodology.
- b. Additional classification for capacities other than USAR
 - a. Would require extensive resources.
 - b. This will increase commitments from the teams and the INSARAG Secretariat.
- c. The AP Region is committed to provide more inputs and recommendations on Flexible Response, if required.

Recommendations to ISG in concept paper:

Part 1 – Existing Capabilities:

- 1. ISG endorses the concept of "beyond the rubble" flexible response of existing capabilities for formalisation and adoption.
- 2. ISG endorses the concept of "FlexR" for modular response of <u>existing</u> capabilities of member's USAR teams for formalisation and adoption.
- 3. ISG **notes** that endorsing 2 above will **require further work including development of new guidelines outlining** the process for FlexR responses.
- 4. ISG notes that the provision of Beyond the Rubble and FlexR by member teams will be on an "opt in" basis





Recommendations Part 2 - Additional Capabilities

For information of ISG:

- endorsement of this section is a policy decision for the ISG
- builds on the mandate provided by the ISG to the Flexible Response Working Group to develop this concept.
- expansion of mandate is in keeping with the general meaning of, but not specifically detailed in the UN General Assembly resolution 57/150.
- INSARAG/OCHA consider updating UN resolution, and INSARAG Vision and Mission statements if so endorsed.
- These endorsements will require further work and result in an expansion of the capabilities offered by the INSARAG member USAR teams on an "opt in" basis
- 5. ISG endorses the concept of developing additional modular capabilities to be added to member's USAR teams as outlined in the concept paper.
- 6. ISG notes that in endorsing 5 above, further work will be needed to:
- prioritize and endorse each new additional capability (initial list in paper)
- development new standards/training requirements, guidelines, extension of classification processes for each team offering each new capability under INSARAG.





Recommendations Part 3 – Interim Steps (additional capabilities registration)

7. ISG endorses:

- Establishment of a register of INSARAG member USAR teams that will "opt in" to the provision of Beyond the Rubble, FlexR and additional capabilities that they are prepared to deploy.
- These capabilities will be matched to requests for assistance by the Secretariat on a bilateral basis during the period that formalization of the above endorsed changes are developed.
- To register an interim additional capability the member will need to identify the national authority and standard that capability meets.

BACKGROUND

Partnership: boost and develop partnership for sustainable participation, ownership and governance (Strategic Objective 4 of INSARAG Strategic Plan 2021-2026)

Objective 4.1:

Strengthen collaboration and coordination, expand established technical partnership and harness the collective synergies of national expert members for effective coordination and stronger preparedness.

Objective 4.2:

Promote a broader outreach and increased engagement with new relevant partners in preparation for a collective response in case of disasters.

Operational Interoperability between JOCCA and OSOCC (ASEAN – OCHA Partnership Roadmap)

In the event both offers to establish JOCCA and the UN-led On-site Operations Coordination Centre (OSOCC) have been accepted by the affected government, where possible, the OSOCC and JOCCA will be co-located

By preference, the site of the JOCCA-OSOCC should be at or near the NDMO.

The possibility co-location should be explored by the team leaders of the ASEAN-ERAT and the UN Disaster Assessment and Coordination (UNDAC).

However, if it is not possible due to the limitation of space or other constraints, exchange of information and/or other liaison exchange shall be made available to ensure that the response efforts are harmonised to support the affected government.

Where deployed to support either the UNDAC or ERAT and where the OSOCC and JOCCA are co-located, support partners such as Télécoms Sans Frontière (TSF), MapAction – all of which have partnership arrangements with both UNDAC and ERAT – may jointly support both teams.

Recalling the GA 57/150 Resolution

The United Nations General Assembly Resolution 57/150 (2002) on "Strengthening the effectiveness and coordination of international urban search and rescue assistance", tabled by Türkiye, was adopted by 51 sponsoring countries following the devastating earthquakes of Izmit and Jiji in 1999.

The resolution affirms that the contributions made by international urban search and rescue teams are essential in helping to reduce the loss of life and human suffering following disasters. It also recognise the INSARAG Guidelines and Methodology as a flexible and helpful reference tool for disaster preparedness and response efforts, .



Strengthening the effectiveness and coordination of international urban search and rescue assistance – in short:

- Recognizes the importance of international cooperation on humanitarian assistance in the field of natural disasters, from relief to development.
- 2. Highlights the United Nations' key commitment to improving the efficiency and effectiveness in the provision of international urban search and rescue assistance
- 3. Emphasizes the aim of contributing towards saving more human lives

Efficiency & Effectiveness

 Stresses the need to improve efficiency and effectiveness in the provision of international urban search and rescue assistance, with the aim of contributing towards saving more human lives;
